**Coolers are not permitted inside the complex except for one cooler in the dugout for players and coaches. A full concession stand will be open.**

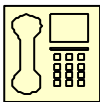
Dugouts will be decided by coin toss before each game. The Home team will be located in the 3<sup>rd</sup> base side dugout.

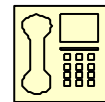

## General Information / Helpful Hints

1. There will be a MANDATORY Team Manager Meeting on **06/30/2023, 12:00 PM**, at the Courtyard Marriot in Tradition at the Bistro Room.
2. The following will be reviewed at the above meeting or before your first game  
**Team Affidavits and supporting paperwork**  
**Medical Release Forms**  
**Diamond Leader Training Certificate for each Coach**  
**CDC – Concussion Protocol Certificate for each Coach**
3. Games will be played in accordance with Tournament Rules
4. Umpires will check all equipment prior to each game – faulty equipment will be removed and will not be allowed to be used.
5. Pitching Affidavits will be filled out completely following each game. The Manager is responsible to assure the Affidavits are accurate.
6. **Teams should arrive at least one (1) hour prior to the scheduled game start time.**
7. Team Warm-Up areas are provided. No hitting balls against the fences.
8. Teams must pick up trash in dugout before vacating.
9. **NO COOLERS** are allowed inside the park (with the exception, the team may have a cooler in the dugout with drinks, wet towels, etc.).
10. The use of tobacco and alcohol are strictly prohibited. Smoking is allowed only in the parking lot areas – No Exceptions.
11. Obscene language or harassment by anyone will not be tolerated. Offenders will be ejected from the park.



## Directions and Map

### Directions to Fields/Park:

#### TRAVELING I-95

Whether you are traveling North or South on I-95, take exit #110, Martin Highway (SR 714) and go East 4.5 miles. You will come to the stop light at Citrus Blvd turn left and head North on Citrus Blvd. In one mile you will come to a light for the school and the baseball park. Turn right into the complex. The fields will be on your right. The fields are professionally maintained by Martin County Parks and Recreation.

#### TRAVELING THE FLORIDA TURNPIKE

Whether you are traveling North or South on the Florida Turnpike, you will need to exit at the Stuart exit, #133, onto Martins Downs Blvd. also known as CR 714. After exiting turn left and head west on CR 714. You will cross over the turnpike and the second light you come to will be Citrus Blvd. Turn right on Citrus and head North. In one mile you will come to a light for the school and the baseball park. Turn right into the complex. The fields will be on your right. The fields are professionally maintained by Martin County Parks and Recreation.
